

GENERAL RELEASE

This is release of liability. Read carefully before signing.

FOR PARTICIPATING IN THE BELOW CAPTIONED SPECIAL EVENT, THE CITY OF SACRAMENTO IS REQUIRING YOU TO ASSUME ALL RISKS BY SIGNING THIS GENERAL RELEASE.

In consideration of being permitted to engage in the 14TH ANNUAL ST. PATRICK'S DAY PARADE & FESTIVAL on SATURDAY, MARCH 13, 2010 in or on City of Sacramento owned or controlled facilities, including streets, ("Facility or Facilities"), I hereby voluntarily waive, release, and discharge the City of Sacramento and Old Sacramento Business Association (OSBA), its respective successors, assigns, officers, agents, employees, volunteers and any and all persons, firms and corporations having any interest in them or any of them from any and all claims, actions or demands of any kind, nature and description, including claims or actions for damages for death, personal injury, or property damage and from any and all liabilities, damage, injuries, action or causes of action either at law or in equity which I have or in the future may have against any such entities or persons or any one or more of them, arising out of or in any way related to or connected with my presence or participation in the Special Event, including but not limited to personal injury, death or property damage caused by my actions, by the actions of any other person present at City Facilities, or by any person providing advice or instruction concerning the Special Event. This release is intended to discharge, in advance, the City of Sacramento and OSBA, its respective successors, assigns, officers, agents, employees, volunteers and any and all persons, firms and corporations having any interest in them or any of them from and against any and all liability arising out of or connected in any way with my presence, participation and activities during the Special Event at any City of Sacramento Facility, even though that liability may arise out of negligence or carelessness on the part of the City of Sacramento or OSBA, its respective successors, assigns, officers, agents, employees, volunteers and any and all persons, firms and corporations having any interest in them or any of them.

I understand that serious accidents, including grave personal injury or death, occur from time to time during special event activities. Knowing the risks, and in consideration of being permitted to participate, I hereby agree to assume those risks and to release and hold harmless the City of Sacramento and OSBA, its respective successors, assigns, officers, agents, employees, volunteers and any and all persons, firms and corporations having any interest in them or any of them who (through negligence or carelessness) might otherwise be liable to me (or my heirs or assigns) for damages. I further understand and agree that this release and assumption of risk is to be binding on my heirs, executors, administrators and assigns.

I have read this General Release, understand that I give up substantial rights by signing it, and sign it voluntarily. This General Release shall remain in effect until revoked in writing submitted to the City of Sacramento, Risk Management Division, 915 I Street, 4th Floor, Sacramento, CA 95814.
